THE 2013 MEETING WAS HELD IN WASHINGTON, D.C.

REGIONAL OUTREACH AND MEMBERSHIP

THE USJC'S OUTREACH AND MEMBERSHIP ACTIVITIES BRINGS TOGETHER USJC MEMBERS IN VARIOUS PARTS OF THE COUNTRY WITH REGIONAL LEADERS INVOLVED IN PROMOTING STRONG U.S.- JAPAN RELATIONS. THROUGH DEVELOPING REGIONAL NETWORKS OF BUSINESS, CIVIC, AND GOVERNMENTAL LEADERS, THE USJC ASSISTS IN THE DISSEMINATION OF INFORMATION ON CURRENT TOPICS RELATED TO U.S. AND JAPAN AND FOSTERS DIALOGUE IN AREA OF MUTUAL INTERESTS. REGIONAL EDUCATIONAL EVENTS WERE HELD IN LOS ANGELES, NEW YORK, HONOLULU, AND WASHINGTON, D.C.

THE USJC ALSO FOSTERS BUSINESS CONNECTIONS IN KEY REGIONS IN THE U.S. INCLUDING NEW YORK, WASHINGTON, D.C., LOS ANGELES, SAN FRANCISCO AND HAWAII BY FOSTERING NETWORKS OF JAPANESE CHAMBERS OF COMMERCE IN THE U.S. AND JAPANESE AMERICAN LEADERS IN THESE REGIONS. REGULAR EDUCATIONAL PROGRAMS AND NETWORKING EVENTS ARE HELD TO DEEPEN BUSINESS AND PERSONAL RELATIONSHIPS. AN ANNUAL MEETING OF THAT BRINGS TOGETHER THE REGIONAL BUSINESS NETWORKS IS HELD AT THE TIME OF THE USJC ANNUAL MEETING.
