The Japanese American Leadership Delegation Program (JALD), has been organized by the Ministry of Foreign Affairs of Japan since 2000 to promote mutual understanding between the Japanese American community in the United States and Japan, and to strengthen long-term relationships between the two countries. In 2023, 10 Japanese Americans active in various parts of the United States will be invited to Japan for one week, to visit Tokyo and Shizuoka Prefecture to interact with a wide range of intellectuals from the political, public, and private sectors. As part of this program, the Japan Foundation holds this symposium jointly with the US-Japan Council to promote understanding between the Japanese American community in Japan and to promote US-Japan dialogue on diversity and social inclusion.

In the first part of the program, Dr. Curtis Takada Rooks of Loyola Marymount University in Los Angeles, California, who specializes in race and ethnic studies, will give the keynote speech about solidary between Japanese-Americans and other minority communities and their roles, referring to case studies of research projects on diversity, equity, and inclusion in civic engagement.

Part II will be a panel discussion moderated by, Mr. Frederick Katayama, a journalist who is also known as a former business news anchor for Reuters Television. Three panelists, all of whom are Japanese Americans who contribute to society in various ways while exercising leadership in the political and business worlds, will discuss the current state of American society threatened by increasing division despite calls for diversity, and the experiences, contributions, and future of the Japanese American community in such a society.

Keynote Speaker

Curtiss Takada Rooks, Ph.D. (Program Coordinator and Assistant Professor, Asian Pacific American Studies, Loyola Marymount University)



Dr. Curtiss Takada Rooks, a critical race and ethnic studies scholar in Asian and Asian American Studies at Loyola Marymount University (LMU), is currently serving in a yearlong teaching fellowship at Sophia University. His scholarship encompasses multiracial & transpacific identity; APIA community based participatory evaluation; and diversity, equity & inclusion with research projects.

Outside the academy, Dr. Rooks brings experience as a diversity specialist for a civil rights law firm, diversity facilitator for the United Methodist Church Japanese American Clergy Caucus & UMC Los Angeles West District.

Dr. Rooks holds a doctorate in Comparative Culture from the University of California, Irvine, a master's degree in Public Policy from Trinity College in CT. Born to an African-American father and Japanese mother.
